AMENDMENT

Central Ground Water Authority, New Delhi in terms of para 42.7 of the Minutes of the 42nd meeting dated 14.09.2018, has decided to authorize Regional Directors/ Heads of Offices of CGWB to grant NOC for ground water extraction by Industries/Projects located within their jurisdiction and extracting/proposing to extract ground water upto 10m³/day.

Accordingly the following amendment to the Statutory Order No. 26-1/CGWA/ Notification-357 dated 25.02.2014 is further made:

For

(3) To evaluate the proposals received based on hydro-geological conditions and recommend the cases to Central Ground Water Authority as per existing guidelines or orders issued from time to time and also to make correspondence with the project proponents for clarifications etc.

Read as

(3) To evaluate proposals received based on hydro-geological conditions and grant NOCs to Industries/Projects for ground water extraction as per the existing guidelines, in case the water requirement is upto 10m³/day and recommend proposals of Industries/Projects with ground water requirement/usage beyond 10m³/day to the Central Ground Water Authority and also to make correspondence with the project proponents for clarifications etc.

The above authorization is without prejudice to the directions of Hon'ble NGT, New Delhi and subject to compliance of directions issued from time to time.
